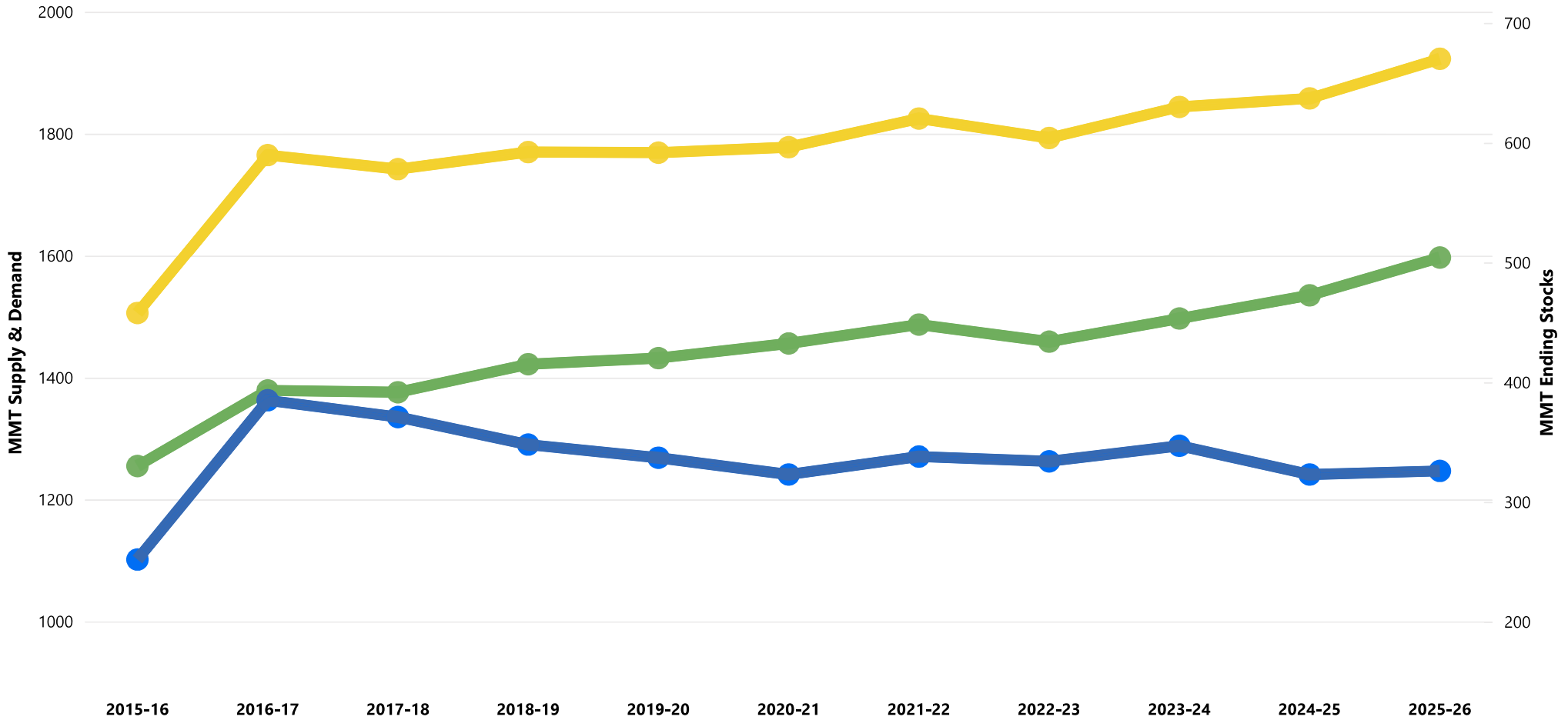

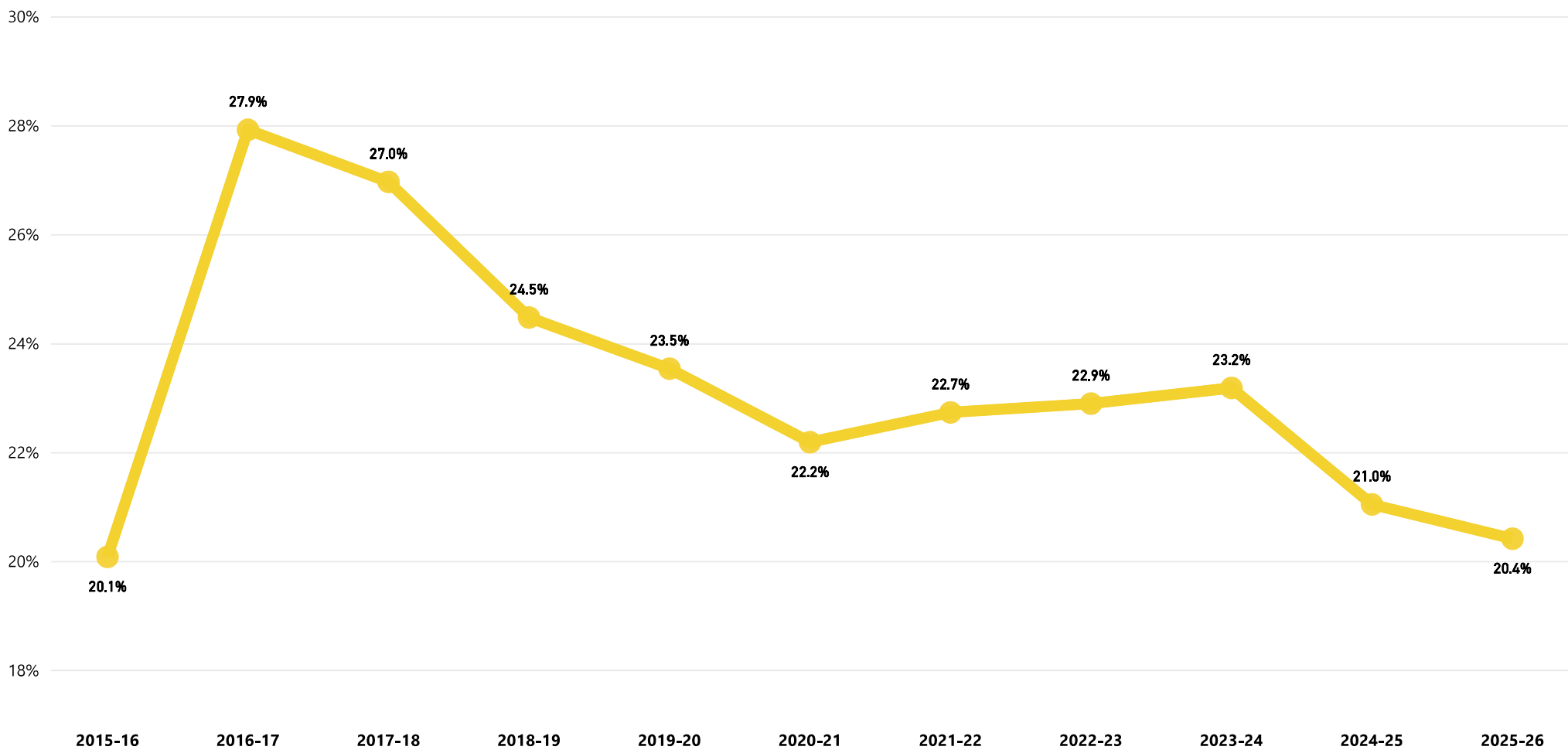
WORLD COARSE GRAIN SUPPLY & DEMAND

Coarse Grains include corn, sorghum, barley, oats & rye.

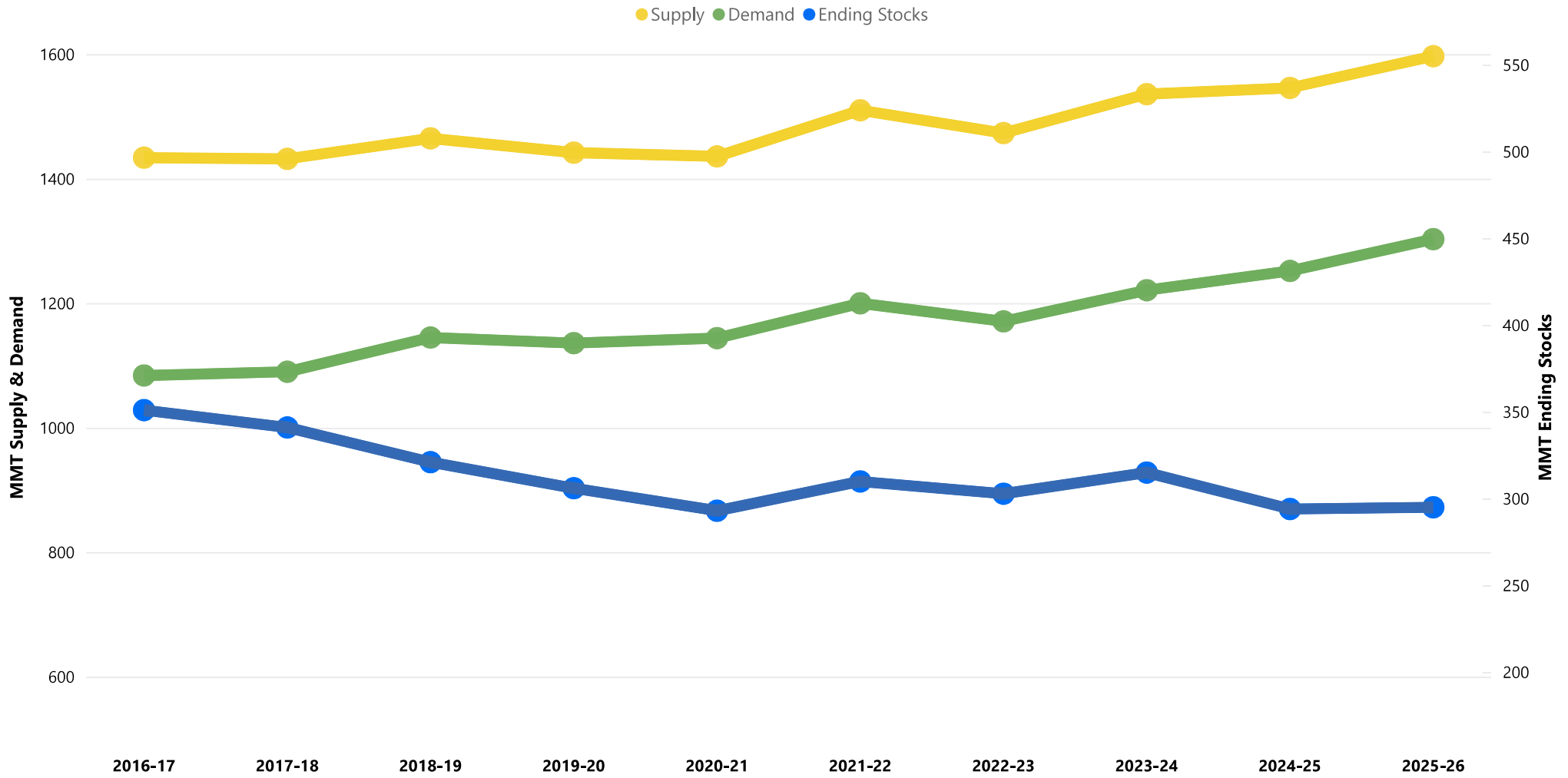

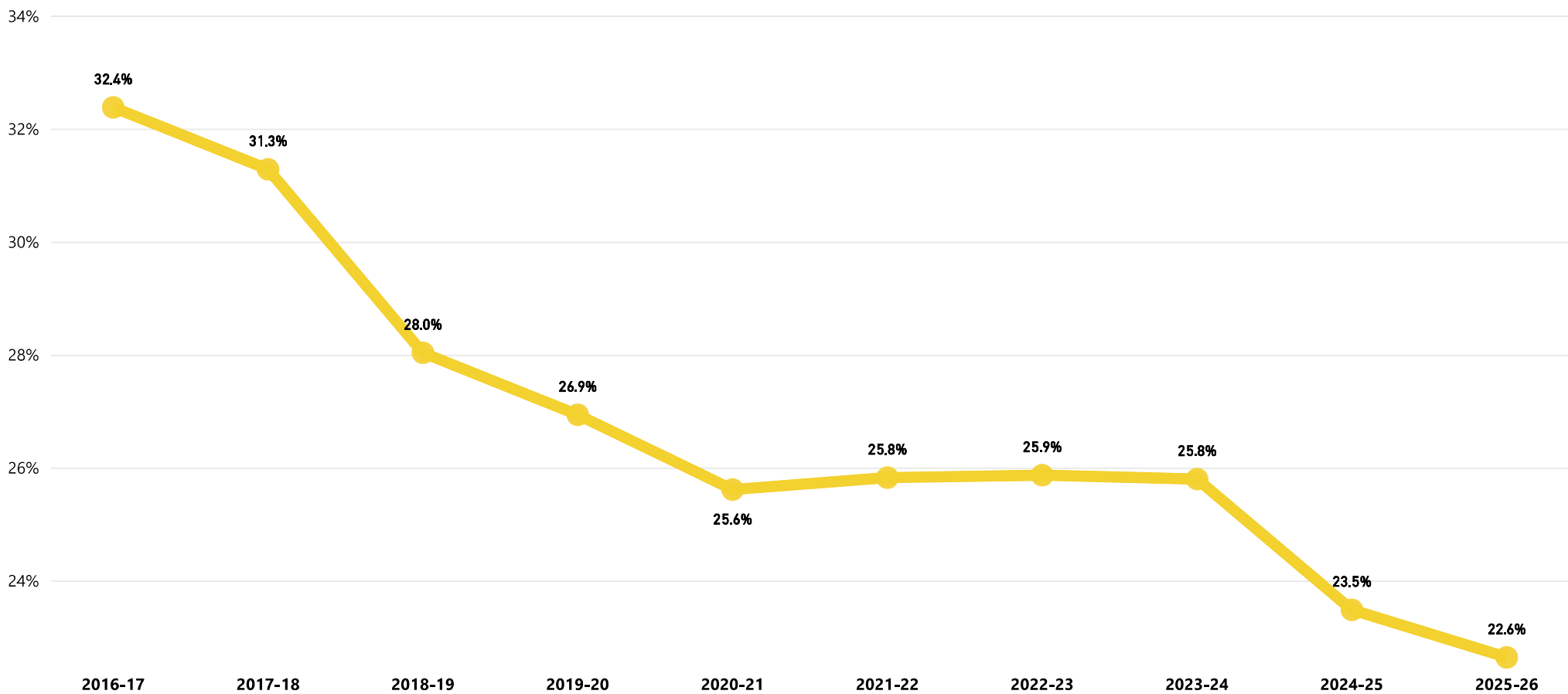
WORLD COARSE GRAIN % ENDING STOCKS / DEMAND



WORLD CORN SUPPLY & DEMAND

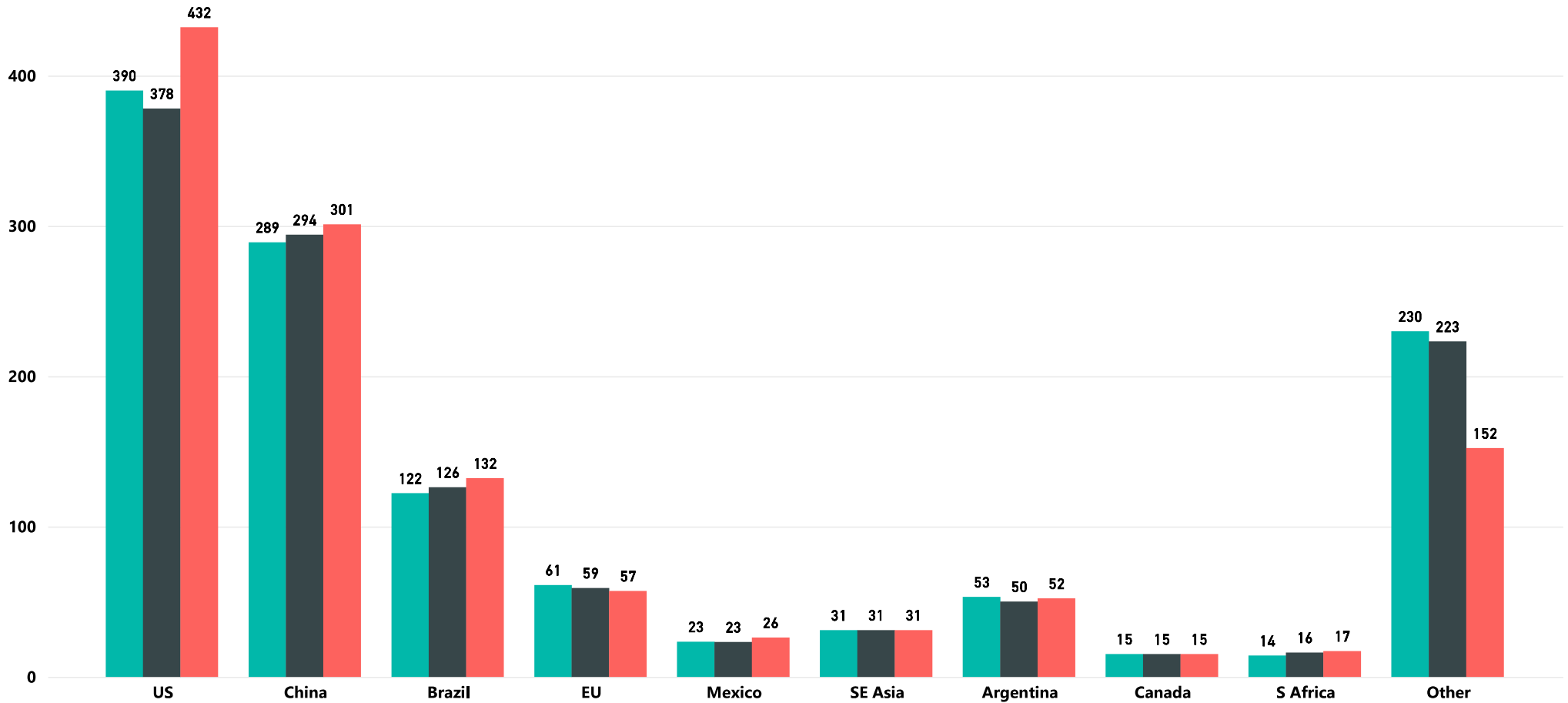


WORLD CORN % ENDING STOCKS / DEMAND

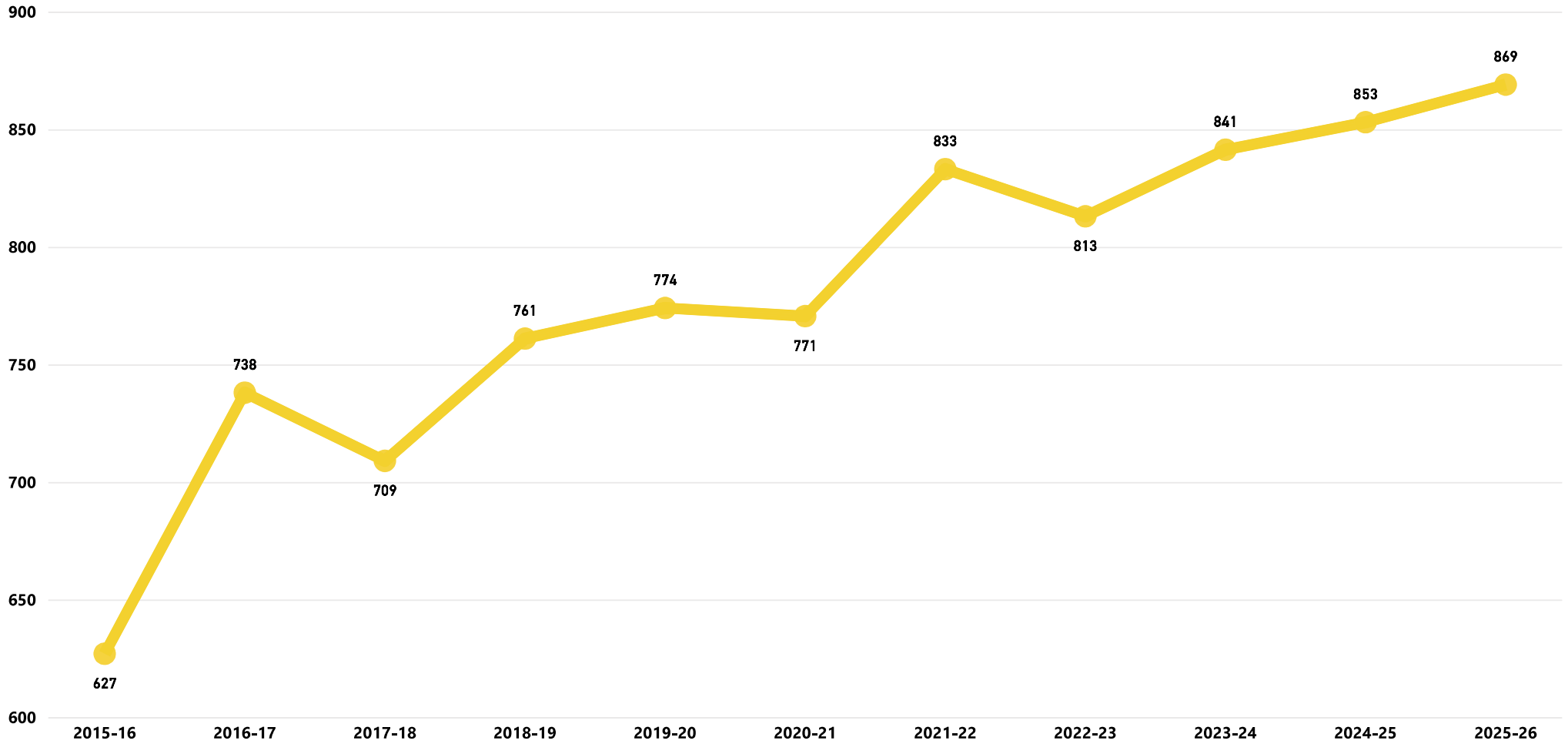


WORLD CORN PRODUCTION

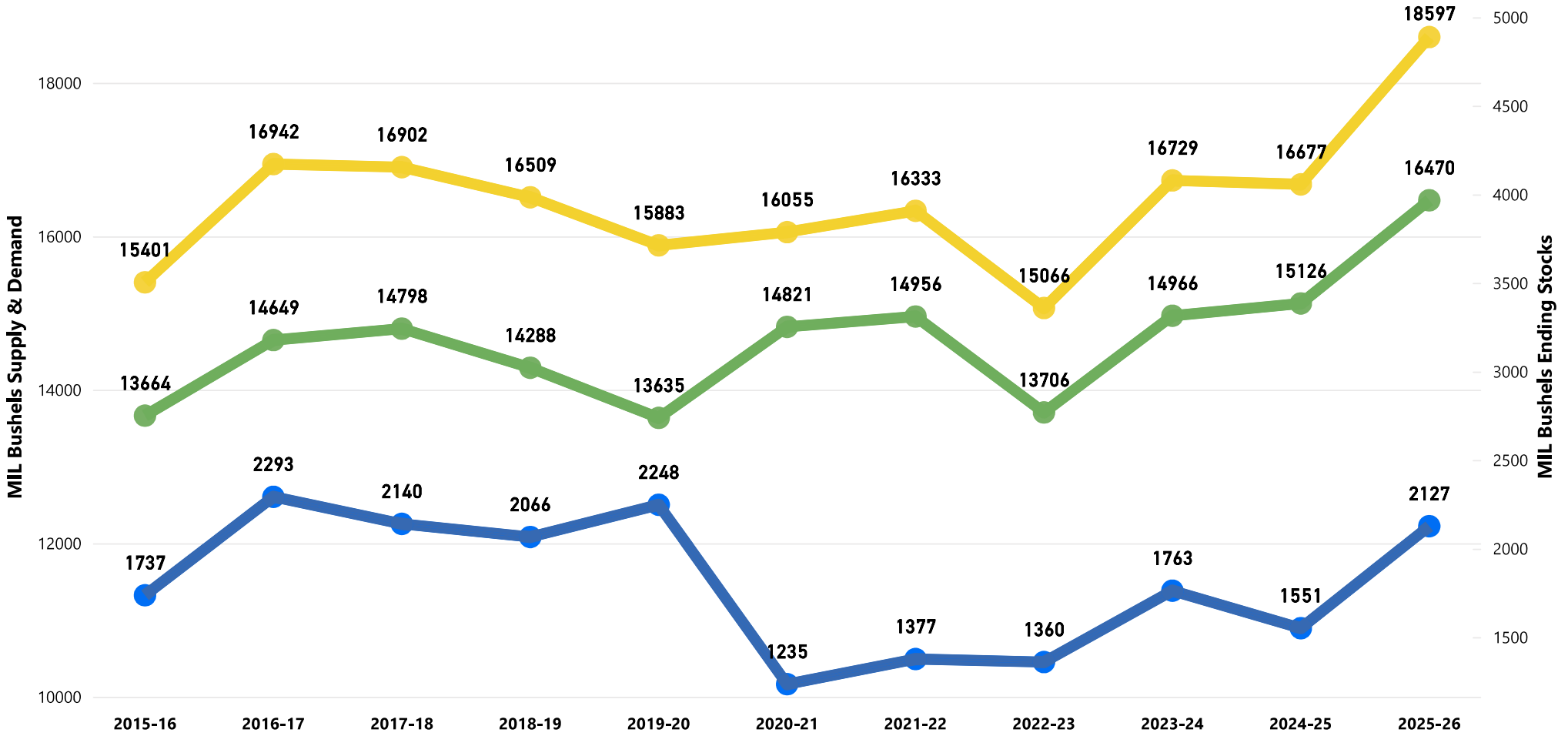
WORLD CORN PRODUCTION MINUS U.S.

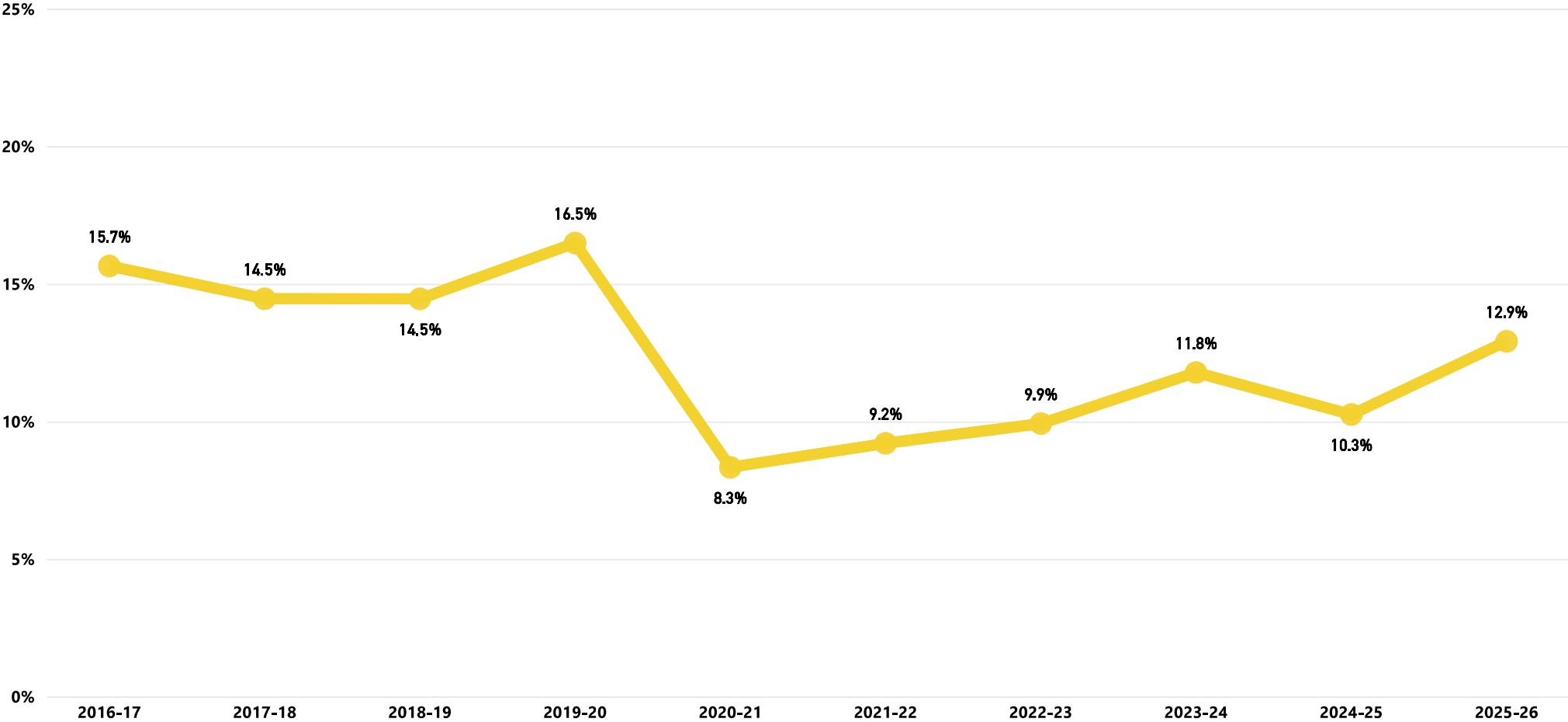

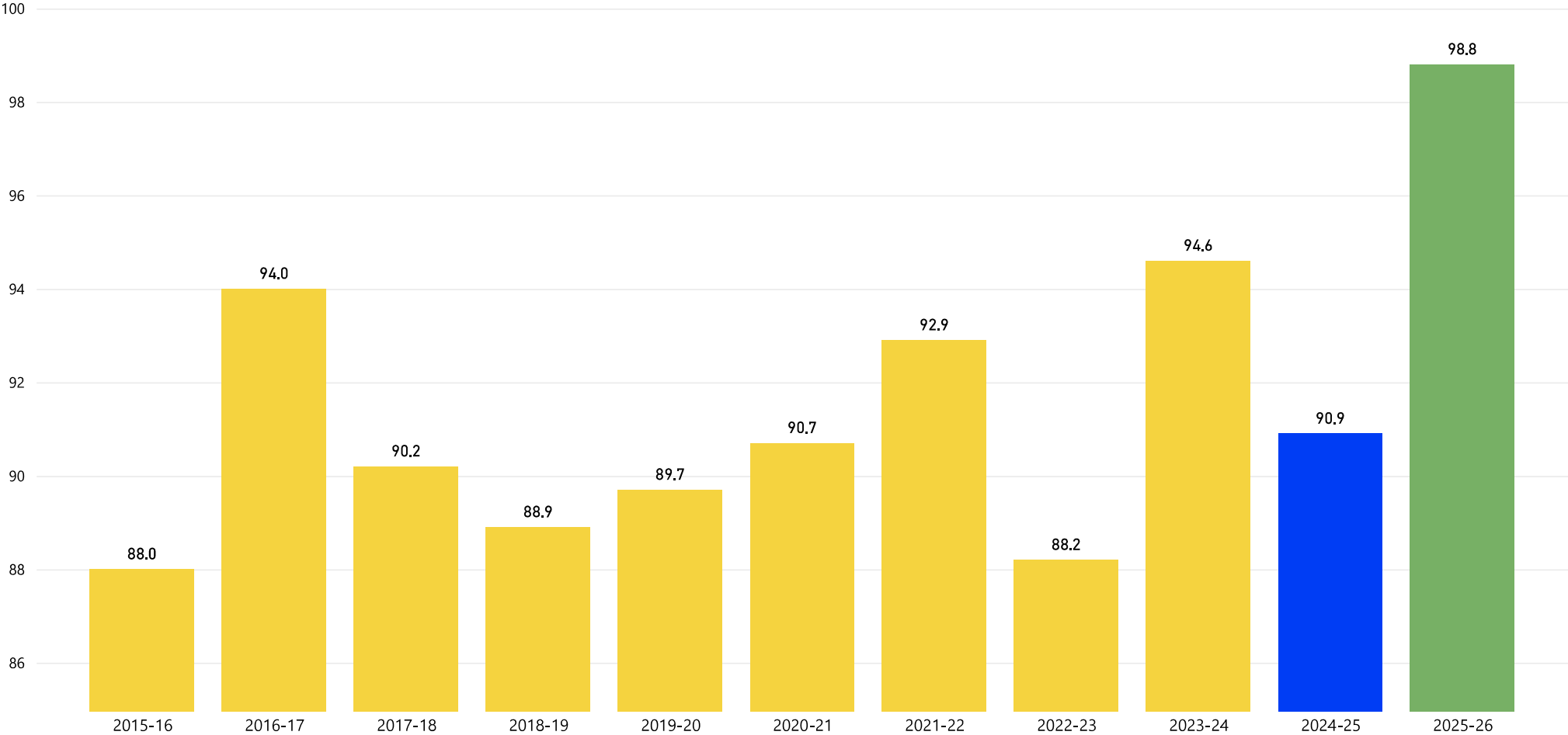

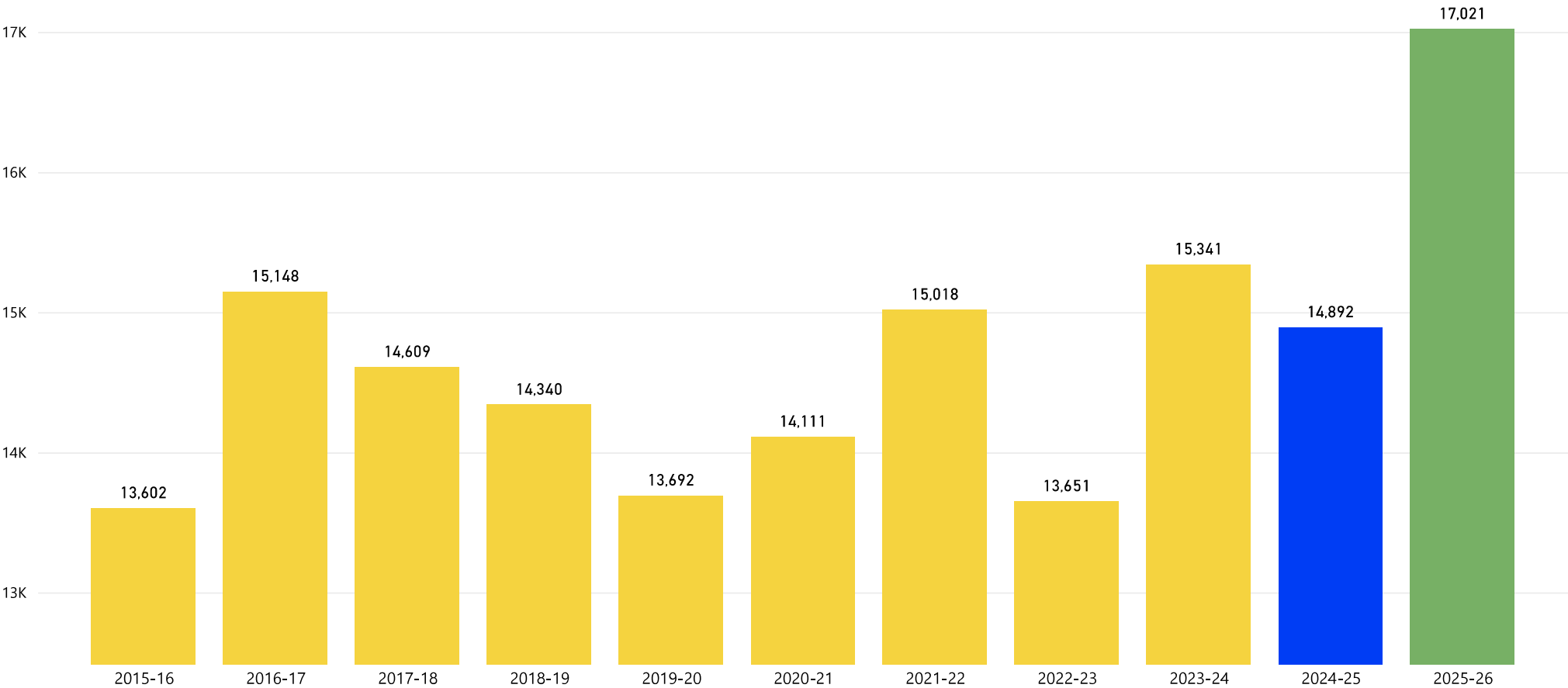

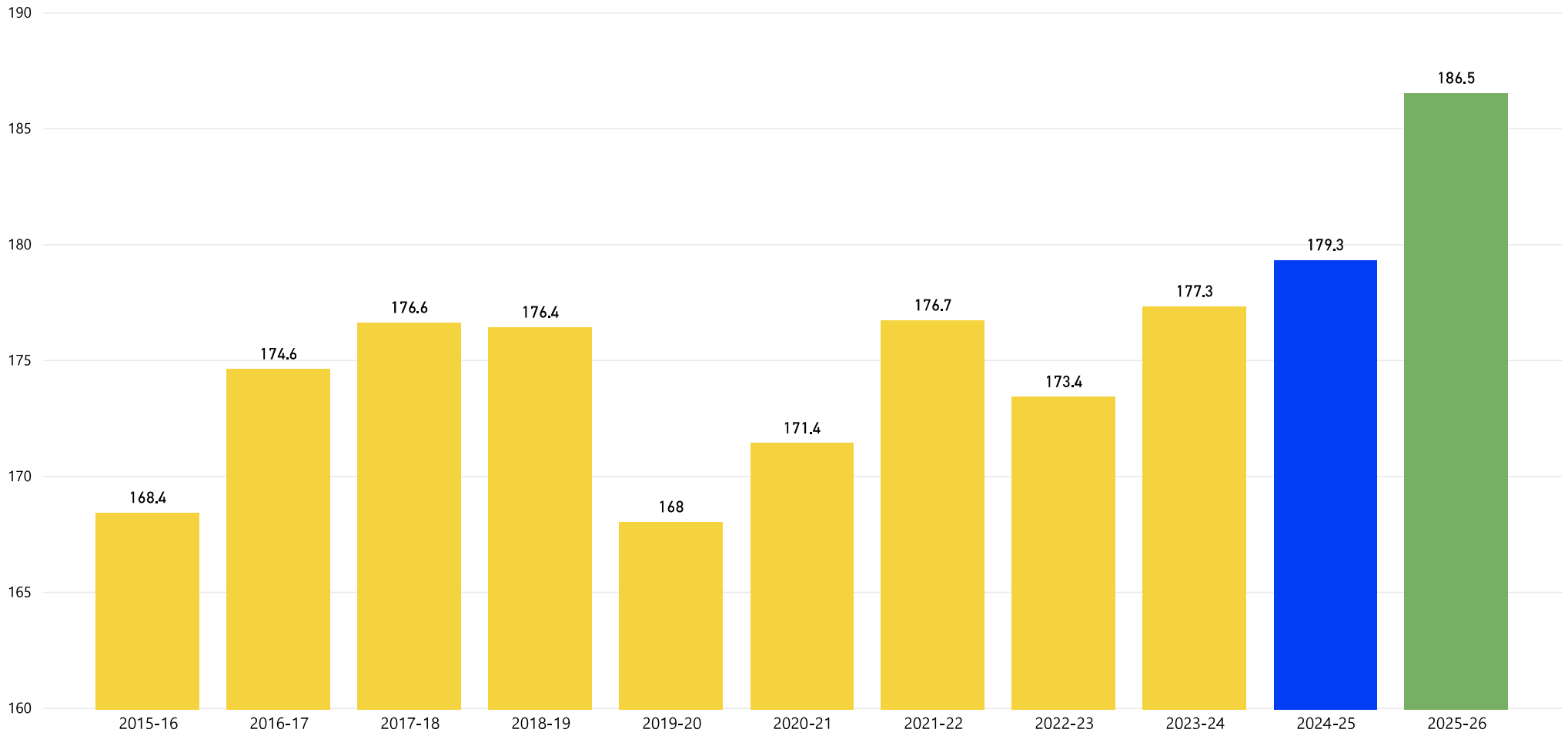
U.S. CORN PLANTED ACRES (MIL/ACRES)



U.S. CORN PRODUCTION (MIL/BUSHELS)

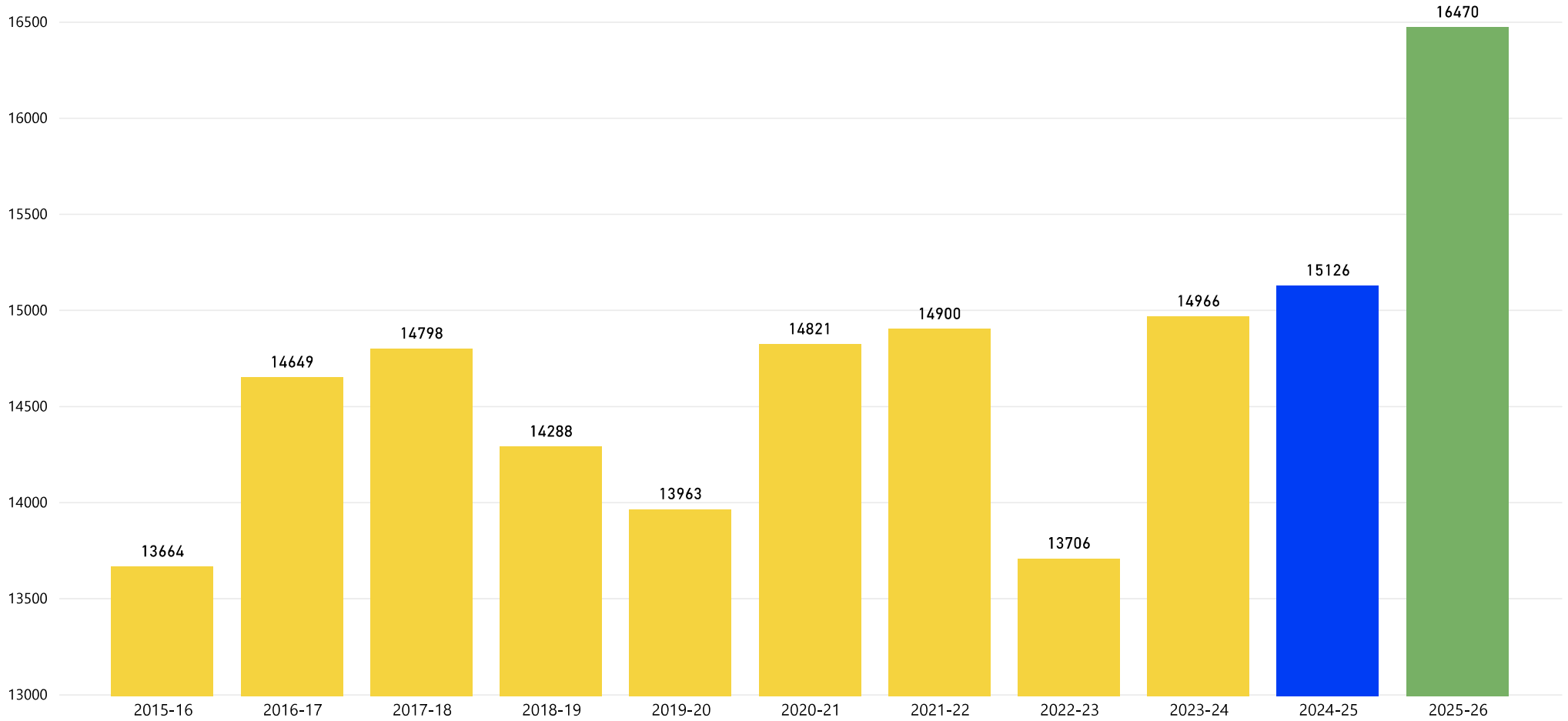


U.S. CORN YIELD (BU./ACRE)

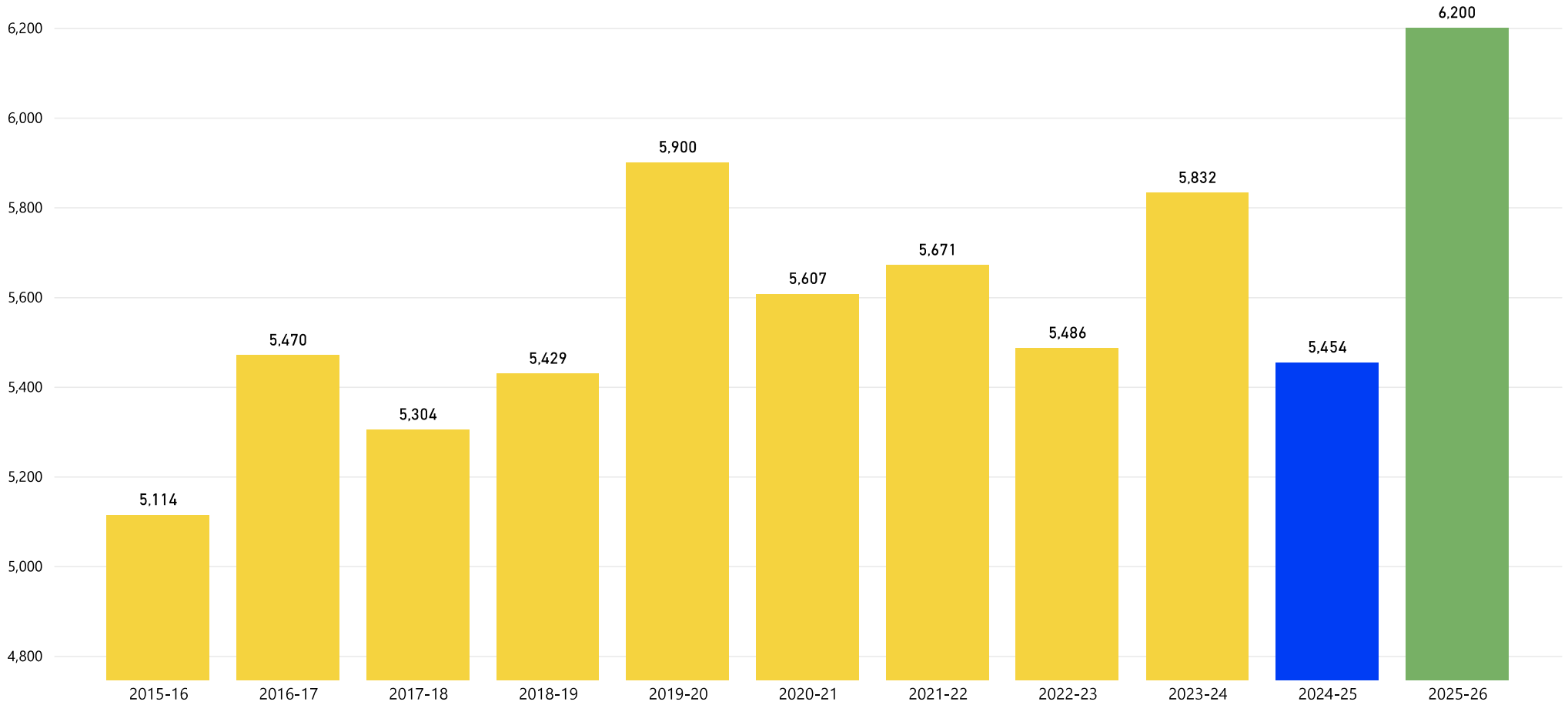

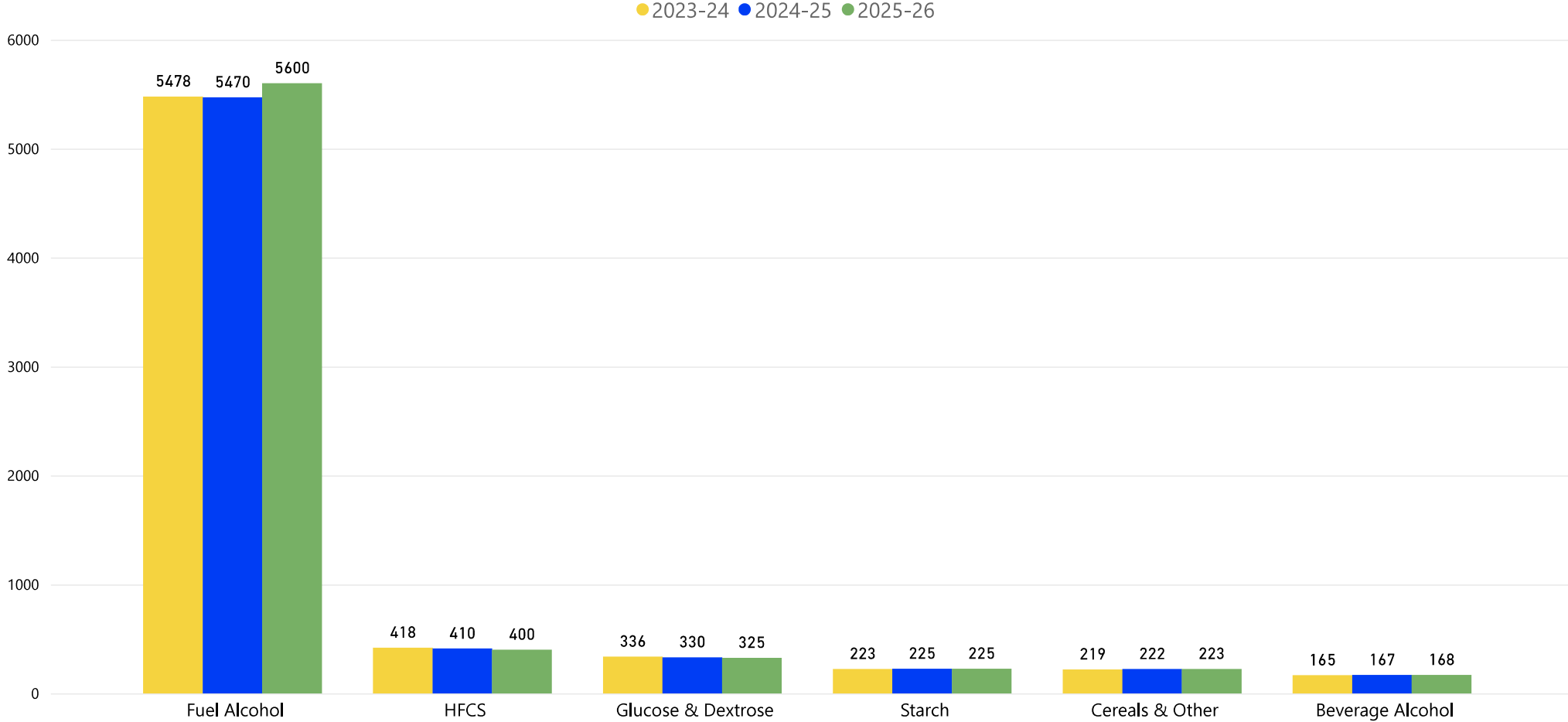
U.S. TOTAL DEMAND (MIL/BUSHELS)



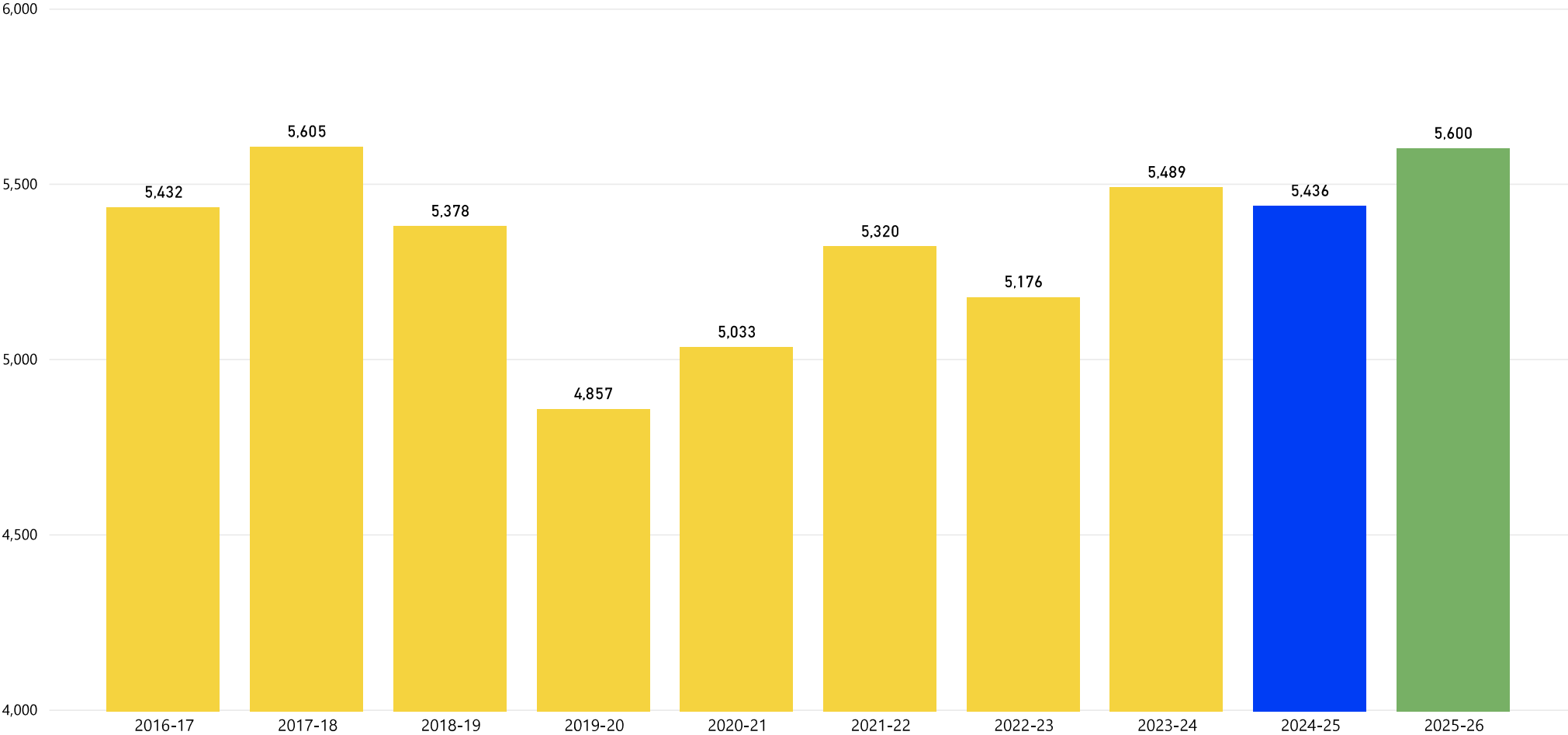
U.S. FEED DEMAND (MIL/BUSHELS)



U.S. INDUSTRIAL DEMAND (MIL/BUSHELS)

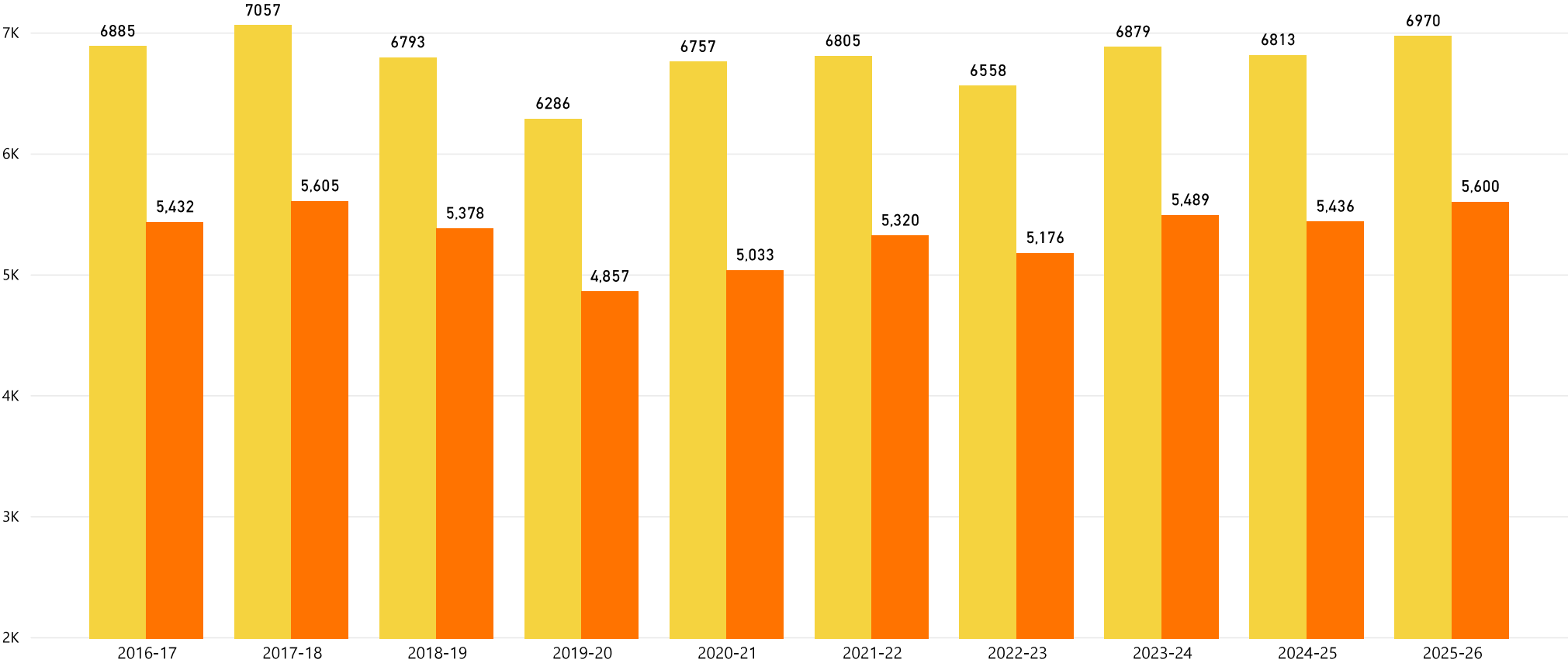


U.S. ETHANOL DEMAND (MIL/BUSHELS)

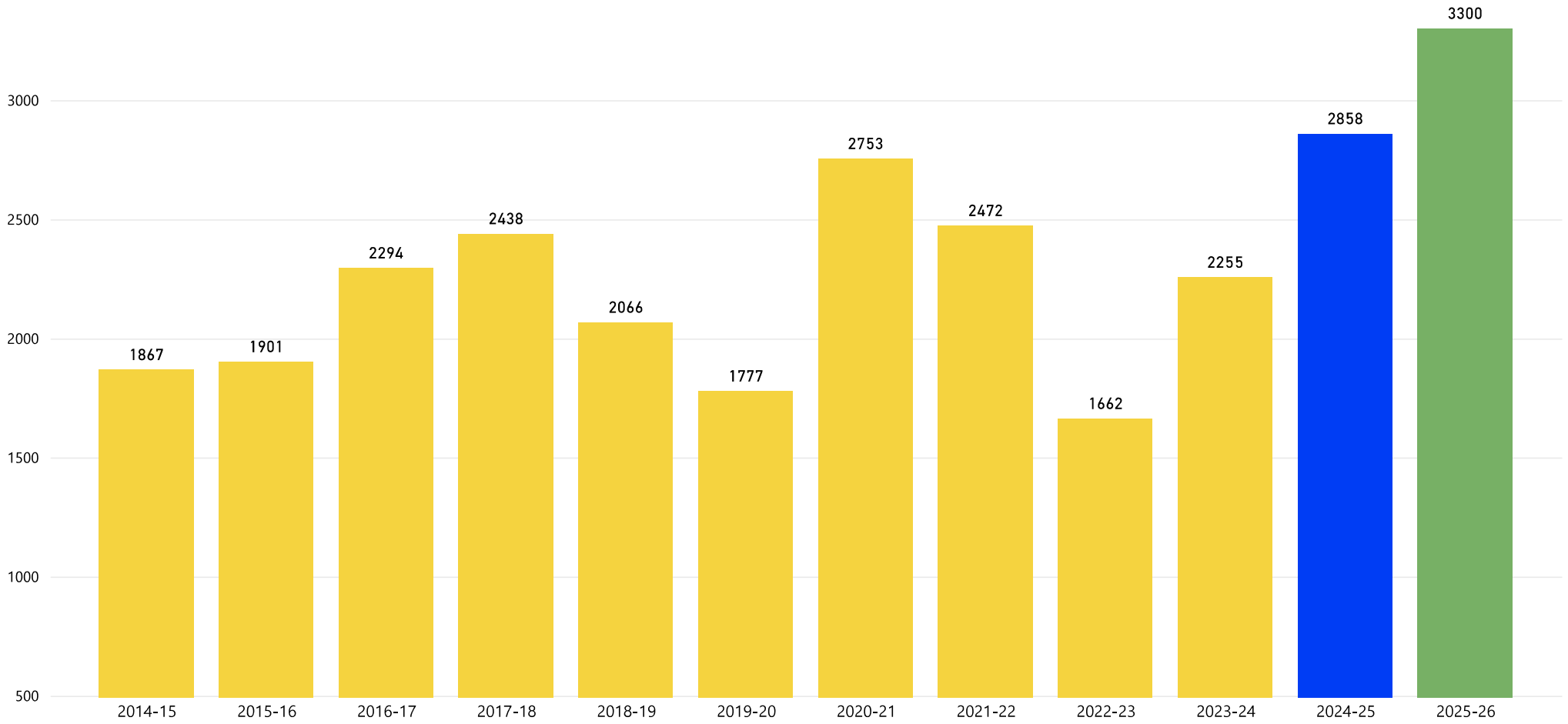


INCREASE IN FOOD SEED & INDUSTRIAL (MIL/BUSHELS)

Summary: WASDE April 2026

- There are no changes this month for the 2025/26 US Corn outlook.
- The 2025/26 foreign coarse grain outlook is for larger production, greater trade, and higher ending stocks relative to last month.
- Global corn ending stocks at 294.8 million tons are up 2.1 million tons.
- The season-average corn price received by producers is raised 5 cents to \$4.15 per bushel.
